Subject: Ministerial Decree on Monitoring and Evaluation

In accordance with the national mandate, this decree outlines the role of the Ministry of Planning and National Development, henceforth MoPND, in monitoring and evaluation and the responsibilities of implementing agencies.

## 1. Objective

To establish a comprehensive framework for the monitoring and evaluation processes to ensure that decisions are based on accurate findings and recommendations, and to regulate actions such as corrections, avoidance of duplication, and project suspension.

# 2. Scope

This decree applies to all projects registered by the MoPND (All projects and programs implemented in Somaliland must be registered by the MOPND). MoPND has the exclusive authority at the national level to conduct M&E activities. No other ministry or institution shares this mandate.

#### 3. Roles and Responsibilities

- a. Implementing Agencies Responsibilities:
  - Implementers are required to follow the procedures and tools set by the MoPND for conducting monitoring operations.
  - Implementers must ensure that all monitoring activities are in line with the MoPND's guidelines and standards.
  - Any findings from monitoring and evaluation activities must be reported to the MoPND promptly and accurately.
  - Implementers must submit any project documents needed to the M&E Department when requested.
  - Implementing agencies must strengthen collaboration and cooperation with MoPND, particularly its Monitoring and Evaluation Department, to enhance coordination, accountability, and data-driven decision-making, ensuring development initiatives effectively improve the lives of the Somaliland people.

#### b. MoPND's Responsibilities:

The MoPND will make decisions based on the outcomes in the monitoring and evaluation reports.
